REQUEST FOR A SERVICE PROVIDER FOR THE REPLACEMENT OF THE UTA SYSTEM FOR THE AIR TREATMENT OF THE CHANCERY APARTMENT AT THE SOUTH AFRICAN EMBASSY IN ROME (14, VIA TANARO).

## 1. PURPOSE

To secure services of a service provider that could replace and install a heating, air-condition and the air treatment system (UTA) of the Chancery apartment at the South African Embassy in Italy, Rome.

## 2. BACKGROUND

The Heating, air condition and UTA system of the Chancery apartment is thirty-eight years old and completely out of order and needs to be replaced.

## 3. **SPECIFICATIONS**

The project will entail the following:

- 3.1 Removal of the current Heating, air condition and UTA system of the Chancery apartment.
- 3.2 Proposed solution installation of a new Heating, air condition and UTA system at the Chancery apartment.

#### 4. RESPONSIVENESS CRITERIA

The minimum requirements that must be satisfied/met by prospective service provider are:

- 4.1 A detailed quotations should be submitted indicating all costs.
- 4.2 Quotes must be in local currency.
- 4.3 Quotes should include VAT.

#### 5. VALIDITY OF PERIOD OF QUOTATION

All quotations must be submitted by the 31 March 2023 and must be valid for a period of three (3) months after the closing date.
