1. PURPOSE

To secure services of a service provider that could refurbish bathroom's accessories of three bathrooms including sanitary ware of the Chancery apartment as well as the replacement of wash basin unit in the laundry at the Chancery apartment, at the South African Embassy in Italy, Rome.

2. BACKGROUND

The Chancery apartment requires the refurbishment of bathroom's accessories of three bathrooms including sanitary ware as well as the replacement of wash basin unit in the laundry at the Chancery apartment, at the South African Embassy in Italy, Rome.

SPECIFICATIONS

The project will entail the following:

- a) Replacement of sanitary ware (toilet), two wash basins, a bath and bathroom accessories (one paper roll holder, two towel holders, two bathrobe holders for the master bathroom;
- b) Replacement of sanitary ware (toilet), two wash basins, a bath, a walk in shower and bathroom accessories (one paper roll holder, two towel holders, two bathrobe holders for the second bathroom;
- c) Replacement of sanitary ware (toilet), one wash basin and bathroom accessories (one paper roll holder, one towel holder for the guest bathroom;
- d) Disposal and transportation of old material, rubble and waste to certified dumping area.

3. RESPONSIVENESS CRITERIA

The minimum requirements that must be satisfied/met by prospective service provider are:

- 4.1 A detailed quotation should be submitted indicating all costs of services required, material and labour costs, including guarantees on materials and workmanship.
- 4.2 A project plan reflecting realistic timeframes, including waiting period for delivery after placing order must be provided.
- 4.3 Quotes must be in local currency.

4.4 A valid registration certificate of the service provider.

4. VALIDITY OF PERIOD OF QUOTATION

All quotations must be submitted by **12:00 on 12 October 2023** and must be valid for a period of three (3) months after the closing date.

5. GENERAL CONDITIONS

The South African Embassy shall not be held liable for any additional costs not stipulated or agreed to after the parties have concluded an agreement.

The South African Embassy will sign the contract with the successful bidder. The South African Embassy reserves the right not to continue with the project and/or appoint a consultant; cancel and/or limit the scope of works.
