1. PURPOSE

To secure services of a service provider that could replace the intercom system at the South African Official Residence in Italy, Rome.

The Official Residence intercom system is more than twenty years old and needs to be replaced.

3. SPECIFICATIONS

The project will entail the following:

3.1 Replacement of the following:

Intercom system with modern technology, including replacement of all related cabling.

3.2 Proposed solution installation of:

New video intercom system with 2Mpx camera wide angle lens

Built-in speaker and microphone Night Vision

TCP/IP connection Compatible with XS-V2003B-2IP

Remote monitoring via the Smart PSS software, phone app or an internal warning

Remote door-unlock

Vandal-resistant anodized aluminum surface

New monitor (7") for the new video intercom system

Microphone and speaker

6 (six) alarm points

Recording of images and messages

4. RESPONSIVENESS CRITERIA

The minimum requirements that must be satisfied/met by prospective service provider are:

- 4.1 A detailed quotations should be submitted indicating all costs.
- 4.2 Quotes must be in local currency.
- 4.3 Quotes should indicate VAT.
